- 590 Hilton Plumbing Repair Revision from last month's meeting
 - This request will cover design and construction
 - Scope: Replace approximately 100 linear feet of 4 inch galvanized pipe with new copper pipe. Ceiling, HVAC duct and lighting will be removed then in the process. Total project cost is expected to be \$325k, and \$275k was requested to be funded by MPEC. The College of Hotel and Restaurant Management proposed to contribute \$50,000
 - The adjusted split amounts do not match the agreed Service Level Agreement and confirmed that request will not be reviewed for funding consideration.
 - MPEC is willing to fund the previously requested amount of \$143,000 and is currently waiting on direction from the College.

PROJECTS NEEDING APPROVAL

590 – Hilton Plumbing Repair – Revision

Justification: The Hilton College of Hotel and Restaurant Management is requesting the replacement of domestic hot and cold water piping located at corridor S149. The piping along the corridor has been leaking due to the deterioration of the old galvanized material.

Project Description: Demo 1,910 SF of ceiling grid and ceiling tiles. Remove and install back 16 light fixtures, 7 smoke detectors, and 4 exit signs. No need to remove fire sprinkler system. Protect 1,910 SF of flooring/ carpet. Demo main HVAC duct approximately 120 linear feet. Replace approximately 200 linear feet of 3 inch galvanized pipe with new copper pipe. (Hot return line through entire hallway). Replace approximately 100 linear feet of 4 inch galvanized pipe with new copper pipe. (Last of galvanized cold water pipe remaining through hall,

Total Project Cost: \$325,000

Approved last month: \$143,000 (MPEC) but held due to the revised request.

Revised: Split \$275,000 (MPEC), \$50,000 (College/Hilton)

Contractor/Crew: General Contractor
