- Is on track to graduate or graduated high school with the Distinguished Achievement Program (DAP) or the International Baccalaureate Program (IB).
- A high school GPA of 3.0 or higher.
- Achieved a college readiness score on the SAT (1590) or ACT (23).
- Ranked in the top one-third of the prospective high school graduating class
- Appointed by the governor, lieutenant governor, state senator or state representative.
- Must submit ORIGINAL "Notice of Selection"

Continuing recipients must meet the following criteria:

- Maintain satisfactory academic progress as determined by the institution.
- Continue to be a member of the Reserve Officers' Training Corps (ROTC).
- Not have earned a baccalaureate degree or completed a cumulative total 150 hours.
