- **Issue/Scope:** This is an amendment to the original request. This is to request an additional \$48,872 as the new total project cost is now \$101,000. The new scope of work includes the removal and replacement of 7 skylight panes and the removal and replacement of sealant at all joints located at all three skylight units. This new scope captures a more permanent solution to the ongoing skylight issue, this will prevent water intrusion for a longer period of time.
