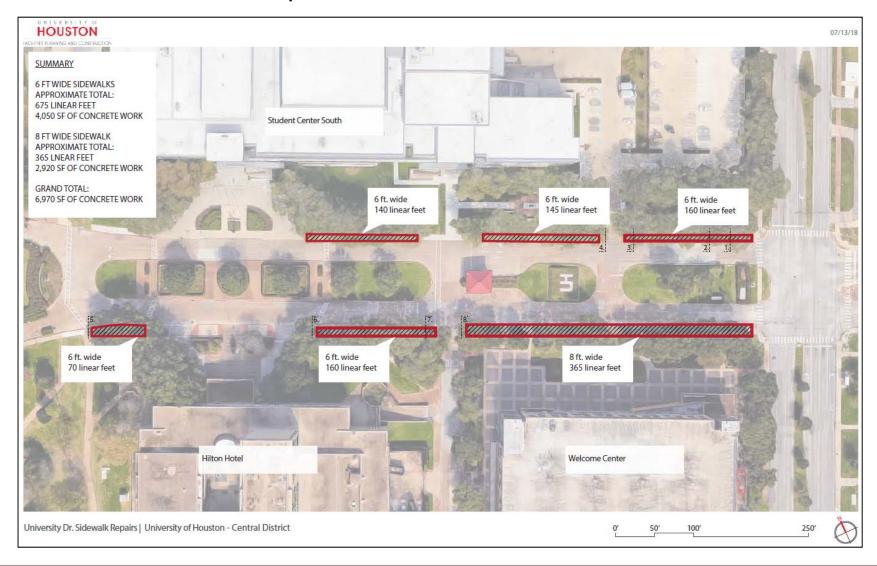

PROJECTS OVER \$50k FOR COMMITTEE APPROVAL

800 Campus, University Dr. Sidewalk Repairs

- **Issue:** Student Government Association (SGA) is requesting the repair of two campus critical sidewalks along University Dr. due to poor condition. Walkways and ramps will be corrected to eliminate trip and slip hazards.
- **Team:** Minor Planned Projects, Design Team and General Contractor.
- **Scope:** Approximately 675 linear feet of 6 foot and 365 linear feet of 8 foot wide sidewalks will be replaced. Project area is limited to 6,970 square feet.
- **TPC**: \$150,000
- Schedule: Design ECD = December
 Construction by end of next summer
- Note: Design for this project will be in line with the Campus Master Plan.
