To ensure that everyone has an equal opportunity to register for Camp Rec 2008 (hereinafter referred to as "Camp Rec"), the following policies are designed to give those who are ready to fully register the priority. "Holding" space is not possible due to the high interest in Camp Rec.

1. To be fully registered, all forms and fees for each session must be turned in at the time of registration.
2. Registrations are taken on a first come, first served basis as long as all registration forms and fees are received in the Campus Recreation and Wellness Center main office.
3. Registrations can be received in the Campus Recreation and Wellness Center Welcome Desk or via mail service.
4. If the parent or guardian is claiming to be a member of the Campus Recreation and Wellness Center, they must also submit their Cougar Card One number so that membership status can be verified.
5. Waiting list has no guarantees of registration.

**Release, Indemnification and Hold Harmless Agreement Regarding Camp Rec Activities:** *As the parent/guardian of the above-referenced camper, I am fully aware of the recreation activities that my child could participate in while attending Camp Rec including rock climbing, swimming in a pool containing water over five feet deep, sports, games and activities both indoor and outdoor, both on-campus and off-campus, that could include running, jumping, swimming and participating at a level of high exertion, and could include traveling by automobile, van, shuttle, bus, and/ or by any other type of transportation to and/or from any off-campus activities. In this regard, and in consideration for my child's participation in Camp Rec, I hereby acknowledge and accept all risks to my child's health and of injury or death that may result from such participation. I agree to release, indemnify and hold harmless the University of Houston and the University of Houston System, and their governing board, officers, employees, faculty members, representatives and agents (hereinafter collectively referred to as the "University") from liability for the injury or death of my child; or damage to any property that may result from any activities pertaining to Camp Rec, including, but not limited to, those activities stated above, whether caused by the negligence of the University or otherwise. Should my child require emergency medical treatment as a result of accident or illness arising during Camp Rec, I consent to such treatment. I acknowledge that the University does not provide health and accident insurance for participants and I agree to be financially responsible for any medical bills incurred as a result of emergency medical treatment. I represent that my child is physically and mentally able, with or without accommodation, to participate in all aspects of Camp Rec, and is able to be in the presence of as well as use any equipment, materials, and/or supplies associated with such participation. Prior to my child's attendance at Camp Rec, I will notify the Department of Campus Recreation in writing if my child has medical conditions about which emergency medical personnel should be informed.*
