Additionally, one will maintain clinical documentation and job performance benchmarks set forth by supervisor.</p> <p>WITH WHOM WOULD I INTERACT?</p> <p>You would be working with families for pre-admission counseling or coordinating admission and discharge. The position interacts daily with adolescent males and females in a residential setting, the entire treatment team, and support personnel (direct care, nursing, doctors, administration, administrative support, etc.). You will work with primary insurance companies and Medicaid obtaining authorizations for treatment.
