This opportunity would require a commitment of 20hrs per week, running from January through August of 2015 (it is a grant funded part-time position) with the possibility of grant renewal through the Criminal Justice Division of the Texas Governor's Office. The position would entail providing direct services (assessment, service planning, counseling, and some presentations) to Spanish speaking individuals and families who have been impacted by crime or other forms of trauma. This role also requires participation in internal agency collaborations as well as community outreach functions and may be assigned to mentor interns/students.
