<b>Job Description</b>	<ul style="list-style-type: none"> <li>• Conducts in-home or on-site visitations to assess applicant or client social problems/needs</li> <li>• Determines extent of supportive services needed and develops a case treatment plan</li> <li>• Provides information and assistance and refers clients and the general public to appropriate County or community service agencies based on needs assessment</li> <li>• Confers and may work jointly with a variety of public, private community agencies and/or health specialists to obtain or provide information in case assessment or treatment plans, to refer clients or assist in disaster relief, to develop community resources, or to provide certification and/or special assistance to other agencies upon request</li> <li>• Performs liaison work and/or problem resolution with other services agencies</li> <li>• Responds to and investigates complaints of abuse, neglect and/or exploitation of adults and may take or recommend appropriate action</li> <li>• Makes assessments of clients in need of in-home care including evaluation of alternative resources in or out of home</li> <li>• Performs case management functions for these clients including interaction with client's family, providers and others to obtain/provide information, resolve differences and provide other resources needed</li> <li>• Provides guidance and information regarding client's rights to confidentiality and self-determination, family, agency and client responsibilities and legal ramifications or liabilities</li> <li>• Authorizes child care arrangements</li> <li>• Assists clients in processing of supplemental Security Income (SSI) and disability claims and appeals</li> <li>• Assesses barriers to employment for clients in a variety of services programs</li> <li>• Assists clients in finding resources to overcome barriers</li> <li>• Determines job readiness, conducts group or individual orientations and determines sanctions</li> <li>• Provides money management services in conjunction with the Auditor's Officer or other approved payer</li> </ul>
