Mental Health Clinician

This position reports directly to the Clinical Director of United States Veterans Initiative – Houston, in coordination with the USVI Executive Director, State of Texas. The Mental Health Clinician is responsible for the delivery of comprehensive evidenced-based therapeutic services to homeless and formerly homeless veterans living in and outside of the Houston Campus of USVI.

Responsibilities:

- Provides individual and group therapy to clients using evidence-based therapies, practices and protocols.
- Establishes and maintains a professional therapeutic relationship with all clients and potential clients.
- Develops initial and ongoing client treatment plans.
- Provides direct clinical intervention services and crisis intervention services to clients in need.
- Maintains confidential and complete client records.
- Transitions clients from the therapeutic relationship using clinically-based protocols.
- Coordinates and collaborates client services with the VA and other clinicians as appropriate.
- Follows proper clinical protocols on client referrals for needed services.
- Facilitates and/or supervises the facilitation of psycho-educational classes to support the needs of the community.
- Performs periodic peer reviews of case files and ensures that each case file is audited quarterly by the Clinical Director.
- Participates in weekly case conferences with other clinicians and with the Clinical Director.
- In conjunction with the Clinical Director is responsible for implementing and maintaining a therapeutic-living environment at the site.
- Participates in monthly Town Hall meetings.
- Facilitates quarterly mental health fairs at the USVI campus.
- Ensures adherence to clinically-based protocols, and maintains the clinical integrity of the Midtown Mental Health Program.
- Maintains office hours that are conducive to client needs, and an office environment that is conducive to therapeutic effectiveness.
- Provides monthly clinical training for other USVI staff and maintains an annual staff training calendar.
- Ensures programmatic compliance with all State licensure requirements.
- Ensures that all services are provided per grant requirements.
- Implements and maintains a system that tracks, updates, and reports, weekly, monthly and annually all grant program outcomes.
- Performs other duties as required by the Clinical Director and/or Executive Director.



Requirements:

- Master's Degree in Social Science and LPHA status required.
- Professional leadership through oral and written communication skills.
- Broad knowledge of and 2 years of direct clinical experience using evidenced-based therapies, such as CBT, CPT, DBT, and Seeking Safety.
- Professional manner and appearance.
- Experience working with homeless or similar population.
- Ability to take general direction; work independently and within a team.
- Ability to work effectively with diverse group of clients, staff, and community members.
- Prefer knowledge/experience working with veterans.
