Ensures development of annual performance evaluations are completed and appropriate follow-up with actions plans for performance improvement. •As the alternate ensures development of Licensed Child Care Administrator performance, responsible for the administration of child care services according to state licensing standards. Assures program compliance with COA standards, with ORR/DCS policies and procedures and OHS/ICE rules and regulations.
