The DCM Team Supervisor will act a subject matter expert, advising DCM's on assessment of survivors' resources and needs, goal planning, compliance reporting, and resource provision within the case management process. DCM Team Supervisors will maintain situational awareness of their team at all times, updating significant events, monitoring work assignments and travel, and reporting progress towards contract deliverables. Also, DCM Team Supervisor will coordinate and communicate with Data Entry Administrators for each team to ensure all compliance reporting is up-to-date and accurate. Also, DCM Team Supervisors will ensure coordination with Construction Analysis to meet client needs.</p>
