Job Description	To conduct Best Interest Determinations (BIDs) for 80 unaccompanied children (UC) per year referr by immigration attorneys at Catholic Charities of the Archdiocese of Galveston-Houston/Cabrini Center and Catholic Charities in New Orleans, LA.
	The job responsibilities of the Child Advocate include:
	 Conducts Best Interest Determinations (BIDs) for unaccompanied children (UC) in the greater Houston area (approximately 60 per year) and in the New Orleans, LA metropolitar area (approximately 20 per year) referred by immigration attorneys at Catholic Charities of Houston and Catholic Charities of New Orleans, LA. Requires monthly travel to New Orleans, LA to conduct BIDs and convene BID panels up to 12 times a year for approximately 2-5 days per trip.
	 Writes BID reports, including a final recommendation for the child's permanency, which m include recommendations for legal and international protection for UC for whom it is determined not to be in their best interest to return to their country of origin. BID reports w be submitted to the Child Advocate Coordinator for review and feedback.
	 Utilizes a variety of assessment tools, to include interviews with the child and the family as well as corollary service providers, to include the child's immigration attorney and post- release service case manager, if available.
	 Requests an international home study or a U.S. based home study through one of ORR/DCS network of Home Study providers as applicable/needed.
	 Identifies immediate and long-term psychosocial needs for UC referred for a BID and make recommendations for appropriate referrals.
	• Ensures that children who are repatriated are connected with social services aimed at their safe reunifications and reintegration in their countries of origin.
	 In consultation with the Child Advocate Coordinator, develops and cultivates crucial relationships with local stakeholders, to include Immigration Judges, immigration attorneys federal stakeholders, and potential members for BID panels.
	 Provides training to local stakeholders on BID guidelines and the process of determining the best interest of the child
	 Convenes BID panels to determine immediate and long-term protection needs and to identified durable solutions for referred cases. Selects panelists based on unique needs of case.
	Liaises with immigration attorneys on specific cases, as needed.

- Responsible for inputting demographic data, reasons for referral, and outcomes of BIDs in tracking mechanism provided by the Child Advocate Coordinator.
- Provides data to Child Advocate Coordinator for inclusion in the quarterly and annual reports and for ad hoc reporting as needed and requested.
- Maintains case file documentation, including updated case notes, and confidential case file management system.
- Assists the Child Advocate Coordinator in the development of assessment tools and BID guidelines.
- Identifies trends and gaps in care and informs Child Advocate Coordinator accordingly
- Conducts research and remains knowledgeable of current evidence-based practices for best interest determinations and child advocate services and complex mental health/trauma, medical, safety, and juvenile justice issues that impact UC.
- Responsible for other duties pertaining to the Safe Passages program as assigned.

General Responsibilities, Children's Services

- Remains knowledgeable of all federal government and USCCB/MRS guidelines, policies and procedures related to the Child Advocate program.
- Participates in monthly Special Programs team meetings (via phone and/or Skype) and regular MRS all staff meetings. Participates in family reunification and/or foster care team meetings as necessary.
- Engages in USCCB/MRS quality assurance and evaluation activities.
