Job Description	<p>The role of the Social Worker/Youth Advocate is to provide holistic, strengths based and comprehensive services to CYO clients (ages 16 to 24 years) while supporting their efforts to move from crisis to independence. The Social Worker/Youth Advocate will harness community resources to meet the needs of homeless youth as they transition from homelessness to independence.</p> <p>Essential Duties and Responsibilities include the following, but not limited to:</p> <ul style="list-style-type: none"> • Assessment and Planning: Provide holistic and comprehensive services including initial assessment, goal setting, long-term service plan development as well as ongoing service plan development, monitoring and reviews. • Youth Engagement: Facilitate and collaborate with youth to develop their comprehensive Individual Development Plan. Promote empowerment of youth - self-management. Encourage and recognize steps towards achieving the youth's goals through individual, family and group counseling. • Service Delivery: Identify and engage appropriate service providers for each client. Create and lead virtual service provision team to plan, coordinate, monitor and measure service delivery, results and outcomes. • Client Satisfaction: Measure client satisfaction; develop improvement initiatives and engage collaborative team to implement changes. • Identify Service Requirements: Determine the extent of need for a particular service; identify potential partners. Utilize teaching, learning and counseling skills to serve the needs of the homeless youth. • Analysis, Reporting and Improvements: Utilizing the HMIS system, track services to clients as well as provide reports for various funders. Develop and circulate appropriate reports to keep all stakeholders informed of progress. Identify and participate in research activities through data analysis and collection. Provide feedback, factual analysis and recommendations for continuous improvements. • Policy and Process Improvements: Recommend changes to the CYO Program Director that improve the quality and effectiveness of the

service and support provided to the clients.

- Flexibility: Display the ability to work a flexible schedule to accommodate project needs and be visible during the hours when youth are out in the community. Perform all other duties related to the job as assigned by the Program Director and Alliance Executive Team.

All Staff Must:

- Adhere to the Social Work Code of Ethics and maintain and protect client confidentiality.
- Promote and demonstrate appropriate respect for cultural diversity among clients, co-workers, collaborative partners and all work related contacts.
- Pass employment checks which include criminal background checks, past employer/reference checks, drug screening, education and licensure verification and driving record checks.
- Attend work regularly in accordance with agency leave policy.
- Maintain valid Texas Driver's License and Automobile Insurance.
- Present a negative TB test within 10 days of original hire date
- Maintain required training hours as per licensure and/or agency policies.

Minimum Education and Training:

Bachelor's Degree in social service-related field required. LMSW or LCSW preferred, with experience in Trauma Informed Care and Motivational Interviewing

3 – 5 years Social Work or Counseling related training and experience, particularly trauma based
