<b>Job Description</b>	<p><b>Job Purpose:</b> Identify and address psychological, psychiatric, emotional and serious behavioral concerns of residents upon admission and during their course of stay at the residential facilities. Furthermore, a therapist is expected to assist in providing safe and secure custody of children to reduce the potentially negative effects of incarceration while accentuating socially acceptable behavior.</p> <p><b>Essential Functions:</b></p> <ul style="list-style-type: none"> <li>• Assist in coordination and management of the unit’s referral system.</li> <li>• Conduct psychosocial/clinical assessments and supportive psychosocial counseling for juveniles.</li> <li>• Provide individual, group, crisis, and family counseling.</li> <li>• Identify and refer youth for psychiatric services.</li> <li>• Provide special attention intervention as needed for all youth and be available for 24-hour emergency call.</li> <li>• Perform in the capacity of team leader in the coordination of staffing and programming of assigned juveniles on special attention status.</li> <li>• Maintain thorough and timely clinical records in accordance with Health Services and Residential Services policies and procedures.</li> <li>• Provide relevant clinical/administrative functions such as clinical staffing, medication monitoring, staff training, managing juveniles’ visitation system, and other duties as designated by immediate supervisor or division administrator.</li> <li>• Provide advocacy and collaborative efforts to ensure relevant services are provided to assigned juveniles.</li> </ul>
<b>Qualifications</b>	<ul style="list-style-type: none"> <li>• Licensed Professional Counselor (LPC), Licensed Clinical Social Worker (LCSW), Licensed Marriage and Family Therapist (LMFT), or Licensed Psychological Associate (LPA).</li> <li>• Minimum of two years post graduate experience working in a clinical setting of which at least one year included working with juveniles.</li> <li>• Applicants may substitute one year of post master’s clinical experience with at least two (2) semesters of internship in</li> </ul>

	the Psychological & Social Services Unit of Harris County Juvenile Probation, or in MHMRA Children's Forensic Unit.
