The responsibilities of this position include: teach doctoral, graduate, and undergraduate level courses in Social Work; assist in Ph.D. student research and dissertation studies; and engage in scholarship, research, grantsmanship, and service. Established in 2008, the College of Behavioral & Community Sciences is breaking new ground by combining knowledge gained through the behavioral sciences with knowledge gained from the community. Our emphasis on behavioral science reflects a focus on individuals, emphasizing behavioral research that examines the problems and challenges people encounter, as well as their need for clinical and supportive services. Our emphasis on community science reflects our commitment to understanding the larger contextual factors that have an impact on the well-being and safety of individuals and their families, such as the effectiveness of systems and policies that impact and support the well-being of individuals. We accomplish this by engaging community and neighborhood stakeholders in a partnered, participatory manner and by collaborating with local, state, and national organizations in both the public and private sectors.

The College of Behavioral & Community Sciences serves more than 2,600 students with seven undergraduate, nine masters, and five doctoral programs housed in seven academic departments/schools: Aging Studies, Child & Family Studies, Communication Sciences & Disorders, Criminology, Mental Health Law & Policy, Rehabilitation & Mental Health Counseling, and Social Work.

Undergraduate programs are offered in the areas of Behavioral Healthcare, Criminology, Gerontology, Interpreter Training; Long Term Care Administration; Social Work, and Speech, Language & Hearing Sciences. Master's programs are offered in Applied Behavior Analysis, Criminology, Criminal Justice Administration, Gerontology, Rehabilitation & Mental Health Counseling; Social Work, and Speech-Language Pathology. Doctoral programs are offered in Aging Studies, Applied Behavior Analyses, Audiology, Communication Sciences & Disorders, Criminology, and Social Work. In addition, BCS collaborates with the College of Public Health in offering graduate programs in Behavioral Health.

In addition to formal degree programs, the College offers eleven graduate certificates and one undergraduate certificate.

The College is the home of the Louis de la Parte Florida Mental Health Institute, one of the largest behavioral health research and training institutes in the country as well as 19 specialized Research Centers and Institutes. Our aim is nothing less than to be among the most influential resources for behavioral and community sciences in the region, nation, and world.

The scholarly work of the faculty in BCS is supported through grants funded by the National Institutes of Health (NIH), National Institute on Aging (NIA), Centers for Disease Control and Prevention (CDC), U.S. Department of Education (DOE), the Substance Abuse and Mental Health Services Administration (SAMSHA), the National Science Foundation (NSF), and the Health Resources and Services Administration (HRSA) among others. With more than \$25 million in new awards in 2013-14, the College ranks second among all colleges within USF's Academic Affairs in external funding.

The faculty published 274 articles in peer-reviewed journals, 12 books, and 79 book chapters. They also made over 400 presentations at international and national conferences in 2013. Ten journals are edited/coedited by BCS.
