 - o An email on this topic was sent to the UH-CDA listsery on 2/4/21.
 - O Benefits: Free shipping available, if departmental unit's paid for a Prime membership for a cardholder, a pro-rated share may be refunded back to the original credit card that paid for it. Please email Pam Muscarello with any cardholders that have a Prime membership UH has paid for, so that Accounts payable office may work directly with Amazon to get that account moved over and refunded.
 - Only Pcard holders will be setup as users for this membership. Cassandra Lopez, Manager, Accounts Payable who oversees Pcard team, will be adding and removing users as their cardholder status changes.
 - o Cardholders will get an email from Amazon to complete their registration.
 - o The email account that will be used will be @cougarnet.uh.edu. Employees that use their UH email address for a personal Amazon account will not have to move to a personal email address.
 - O Please note, Accounts Payable will be locking @uh.edu and @central.uh.edu so that no Amazon Business accounts can be setup on those two domains. If anyone has an Amazon Business account on either of those domains, they will receive instructions from Amazon on how to move that account to a personal email address. If they are a cardholder, Accounts payable can move that account to the new system-wide account. Please inform Pam Muscarello about these.
 - O Amazon will be sending invites to cardholders with instructions for setup. Additionally, a website will be developed with pertinent information before the go live date. (An announcement will be sent as the project gets closer to it).
