MICHELLE MICHOT FOSS, PH.D.

Dr. Michot Foss has been an analyst of U.S. and foreign energy and non-fuel resource development and environmental issues for nearly 20 years. She was named Director of the CBA Energy Institute on July 1, 1995. The Institute is engaged in scholarship and education targeting business and public policy issues associated with commercial energy development worldwide. Dr. Michot Foss conducts research on the political economy of energy, writes frequently on energy issues in Mexico, North America and other world regions and has advised and consulted to a number of U.S. and Canadian energy companies. Dr. Michot Foss is a Shell Interdisciplinary Scholar and project coordinator for two Institute-led studies funded through a special program established at UH by the Shell Oil Foundation. Most recently completed is North American Energy Integration, a comprehensive investigation of continental natural gas and electricity policy and regulatory coordination and market convergence in light of industry trends and the North American Free Trade Agreement. Currently, the Shell team is engaged in Best Practices in Energy Sector Reform, which targets oil and gas upstream developments and the pipeline interface. Best Practices is a feasibility study to develop methodologies for cross-national evaluations, with case studies in the feasibility stage on Russia/Kazakkhstan and Mexico/Venezuela (U.S./Canada baseline). Previously at UH, Dr. Michot Foss was the Shell Graduate Fellow at the Center for Public Policy and also served as coordinator of the Natural Gas Project (NGP), established by Dr. Ken Lay, CEO and Chairman of the Board of Enron Corp. and Mr. Jim Kettleson, former CEO of Tenneco Gas, and now part of the Energy Institute. Dr. Michot Foss led a research effort on natural gas markets in Mexico, which included two conferences, a workshop in Mexico, and production of two working papers for the NGP. Her article, "The Economics of Natural Gas in Mexico -- Revisited" with Francisco Garcia and William A. Johnson, was commissioned for a special edition of *The Energy Journal* on "North American Energy After Free Trade." in 1993.

In 1989-90 Dr. Michot Foss was director of research at Simmons & Company International, investment bankers specializing in oil services. At Simmons & Company, Dr. Michot Foss analyzed petroleum market and oil field service trends and outlooks for financial transactions. At Rice Center, 1985-1989, Dr. Michot Foss was director of research for the Jesse H. Jones Center for Economic and Demographic Forecasting. She managed production of semiannual regional forecasts, energy market and national economic assumptions, semiannual forecast symposia for public audiences, and client-specific studies. Dr. Michot Foss spent the previous three years with the Energy and Minerals Field Institute at the Colorado School of Mines, which conducted summer field seminars on western U.S. resource development for federal officials, congressional staff, journalists and educators. The EMFI incorporated conventional energy technologies, alternative fuels projects such as oil shale and coal gasification, and environmental and socioeconomic issues. In 1983 the EMFI received the International Association of Business Communicators Gold Quill award for excellence. At CSM, the Overthrust Industrial Association, a consortium of oil and gas operating and service companies, funded research conducted by Dr. Michot Foss on the socioeconomic effects of natural gas development in southwestern Wyoming. Dr. Michot Foss also conducted a study of bauxite trade and development in Indonesia during a short-term expatriate residence in Sumatra in 1982. From 1977 through 1981 she worked on environmental and market research studies for a variety of natural resource projects, including coal, uranium, lead/zinc, oil and gas in the Rocky the Mountain states and for Altimira industrial port near Tampico,

Tamaulipas (Mexico) and on editorial review at Texas A&M University for an industry-funded oil spill research program headed by Dr. Jerry Neff (Batelle Labs), which included publication of two books on aquatic and marine hydrocarbon effects; and environmental studies for an electric power generating station on Trinity Bay, Texas.

Dr. Michot Foss frequently publishes and speaks on energy and natural resource topics; is vice president for conferences, International Association for Energy Economic; is a past vice president for the U.S. Association for Energy Economics, affiliate to the IAEE; is program co-chair for the 18th annual North American Conference of the USAEE/IAEE in Albuquerque (1998); is a member of the Board of Editors for *The Energy Journal*; serves on the Petroleum Industry Advisory Board for the University of Southwestern Louisiana; is on the Technical Program Committee for the World Energy Congress in Houston (1998), for which a special program will be held at UH for international students attending the WEC; and is active in other professional and cultural organizations. She holds a B.S. in biology, geology minor, from the University of Southwestern Louisiana; an M.S. in mineral economics from the Colorado School of Mines; and a Ph.D. in political science from the University of Houston. She is a native of Lafayette, Louisiana.
