III Administrative Reports

A Libby Barlow, Executive Director of Academic & Institutional Information and Mary Louis Ochoa, Director of Assessment & Accreditation Services: Update on Quantitative Reasoning and Literacy Information Assessments

Libby Barlow prefaced the Council on General Education assessment with regard to the core competencies at the University of Houston. The General Education assessment was done on behalf of the faculty. It measured literacy assessment, quantitative reasoning assessment and if UH students are meeting these standards. Dr. Barlow mentioned that she will need help from faculty with regards to their input on these assessments.

Mary Louise Ochoa updated the Council on the literacy assessment of students. She began the report stating that information literacy is becoming larger and that it cannot be measured by written products. Information literacy is essentially a process and students need to be observed seeking information. In the assessment, each student was given two questions to research and librarians were charged with watching these students' research process (what they actually did). The librarians noticed that students used ineffective search terms in search engines (i.e., search terms were too general). They also found that students aren't citing information properly. Each piece of assessment was assessed separately by the librarians.

A subsample was used and applied to this assessment.

Quantitative reasoning update: A committee of faculty (from math, philosophy, music, and social science areas) was formed to help assess the quantitative reasoning of UH students (used the EEO definition of math/reasoning of the core curriculum as UH's objective). Using the input from the committee, Mary Ochoa's team created a set of pretest items for quantitative reasoning assessment. She passed out a sample of this pretest document for faculty input (i.e, are these appropriate questions to measure quantitative assessment? Is the level of difficulty appropriate?, etc.). However more embedded student work is needed to make assessments.

Mary would like faculty feedback and thanked everyone for giving her and her team access to information (i.e., Blackboard, etc.) and serving on committees. She mentioned that Assessment and Accreditation Services will come back in the spring to ask faculty for more help.

Q and A session with the Council followed the update.

B Agnes DeFranco, Associate Vice President of Undergraduate Studies

Academic Affairs has not certified graduation/retention data to the CB as of yet. However, the graduate rate is 45.6% and the retention rate is 88.6%.

C Debbie Hermann-Henry, Registrar, Office of Registration and Academic Records

The spring 2011 registration schedule is now posted online. Early (priority) registration will begin November 5, 2010.

D Djuana Young, Executive Director, Office of Admissions

The October 16, 2010 Cougar preview hosted 1200 guests (740 of the 1200 guests were students).

V FYI Document - Djuana Young, Office of Admissions

UC 10879 10F: Procedural change for undergraduates returning to the University of Houston

Djuana Young briefed the Council regarding procedural change for undergraduates returning to UH. The main goals for this procedural change are: 1) for the Office of Admissions to have a better understanding of where students have been (i.e., requiring transcripts if student attended another institution of higher education before returning to UH) and 2) this will help in financial aid processing (i.e., the amount of financial aid is awarded on hours attempted). Also, students returning from academic suspension, will have a better path to changing majors and eventually will improve their future academic endeavors.

Council member Bill Dupré expressed his concerned regarding the \$50 application fee that returning students would have to pay again. He felt that this may make it harder for students to return and succeed. Djuana responded that this standard practice at other peer institutions. Dr. Dupré suggested posting a specific readmission deadline (i.e., July 1). Since this is a new process, the Office of Admissions will be flexible with regards to deadline dates.

VI Old Business

A Unification of Faculty Governance

A Unification of Faculty Governance task force was created (Bill Dupré, María Elena Soliño, and Larry Williams). The task force's goal is to come up with a plan of unification for 2011. Each UH standing council will look at the plan. In the meantime, Dr. Bott encouraged the Council to address any other issues or concerns that may come up via email. He also suggested that we may post email comments to the UC website later on.

B Undergraduate Council Bylaw Amendments

Chair Simon Bott informed the Council that two thirds majority vote was received via email to approve the amendments to the UC bylaws. However, Lawrence Curry pointed out a discrepancy in article III.A.2 with regards to the number of elected college reps assigned to each UC committee. The current bylaws state that "Each voting member of the council shall be a member of at least one standing committee, but the membership of no standing committee shall include more than two elected faculty representatives from the same college or more than one student representatives." Dr. Curry suggested amending the bylaws to say "Each voting member of the council shall be a member of at least one standing committee, but the membership of no standing committee shall include more than three elected faculty representatives from the same college or more than one student representative." As a result colleges with many UC representatives will be in compliance with committee assignments.

A motion to approve this amendment was brought forth, seconded and unanimously approved by the Council.

C Undergraduate Council Attendance

Simon Bott encouraged Council members to attend Council and committee regularly: doing so will indicate to the UH Campus that Undergraduate Council has strong solidarity towards undergraduate education.

D Faculty Advisor Task Force

Charles Peters announced that the Survey Monkey questionnaire form went out to colleges. After information is gathered, the Faculty Advisor Task Force will meet with Faculty Senate's EPSAC committee.

E Course Catalog Punctuation (Kevin Simon)

CBM2 Committee Chair Kevin Simon informed the Council that course catalog punctuation is ready to be implemented. All the appropriate colleges were contacted and will be submitting their changes.

VII New Business

Simon Bott reiterated to the Council that Unification of Faculty Governance will be a major issue throughout the year. He encouraged Council members to communicate issues, ideas, and concerns with him, Larry Williams, Bill Dupré, or María Soliño.
