# Allegations (filed March 1st, 2021 at 12:08PM):

(1) Laura Rincon violated A3S3C1 of the Election Code:

"All candidates are held accountable to the provisions of this code, Student Government Association Constitution and Bylaws and all other University policies. All candidates, by way of registering and running for office, are agreeing to abide by potential sanctions and policies the Attorney General, Election Commission, Supreme Court, and/or designated lower court deem appropriate based on their interpretation of the Student Code of Conduct and University Policy. No sanction will extend beyond the context of an individual or party's involvement with Student Government and/or Student Government practice."

(2) Laura Rincon violated A7S2C12 of the Election Code:

"A Class D violation is a violation of any suspension of campaigning by any member(s) of a party on Election Probation."

Laura Rincon is seen in these screenshots campaigning on GroupMe while banned.

# Defense (filed March 1st, 2021 at 1:51PM):


"The complaint argues that there was campaigning during a suspension. For reference, the suspension placed on the party was from times 10 A.M. to 12:15 P.M. on 3/1/2021, and I urge the Attorney General to confirm these times. These suspensions were due to Complaint 21-07 and 21-19.

The evidence attached does not show Laura Rincon campaigning during these times.

- The first screenshot clearly shows the time that Laura messaged that GroupMe was 9:45 A.M, which is prior to the suspension time frame.
- The second screenshot does not display a timestamp for when Laura's message was sent, it simply displays a time for when the screenshot was taken. This was done on purpose to misconstrue when the message was sent.
- Below we have attached the screenshot which shows when Laura sent the message in the second evidence. The time of this message is 9:38 A.M. It is also clear that the next message in that group chat comes from a member of the Student Action Party, at 10:10 A.M., further showing that Laura did not message during that time.


