Clause 5: Executive and Speaker Reports

- I. Report of the President
 - a. Returned from trip to the White House for conference with Student Body Presidents. Gave a lot of insight and notes for things we can address and research. Presented meal plan issues to the conference on two occasions. It's nice to see that UH is miles ahead of other SGA's in how we operate especially with our agendas and structure.
 - b. Working on dining stuff attempting to find Auxiliary Services Director, still in the search process. Starting task force for meal plans and evaluating how we can make incremental movements to address issues over several years. Involved in accreditation committee, we are coming up on our 10 year cycle. The committee pushed undergraduate research last time, this time the committee is addressing the time frame and subject matter.
 - c. Last meeting, legislation passed through the Senate, I vetoed it due to classifications of the type of bill it was listed. In general I support Classmates, what are the goals and what are the possibilities are key for me to understand where it is going. Main question around the merit of the bill, where will the funding be coming from since the bill requests SGA to support a request for funding. My stance is if we're going to advocate for a staff position, there needs to be clear and convincing data how the funding going there will benefit students better than maybe putting that funding elsewhere. Met with the Dean of CLASS today and it didn't seem likely funding would be there to support a new position.
 - d. Communication Advisors all resigned, all 4. The reasons I've heard about why stem from high number of majors and high number of students to advisors ratio, essentially the concern for a lot of work and limited pay.
 - e. Advising as a whole is an issue across the University, Director of Research looked in to data on the whole matter. Evaluating ways to take loads off advisors, like students assisting students for class planning.

- I. Appointment of Fahad Rehan to the Chair of Internal Affairs -6 10 0
 - a. Fahad I have decent amount of experience being Deputy Attorney General last year, was able to see flaws and problems that exist in our policies and procedures. I intend bringing new and adjustments to the bylaws and election code. Dual Vice-Chairs using Alex Gonzalez and Chris Sanderson. Would like to see revisions to the way appointments to committees are made. Would like to really work on transparency for SGA and the students. Questions?
 - i. Chris What are your goals for IA, short and long term?
 - 1. I have other focuses, but my biggest goal is to really fix the bylaws and election code since there are a lot of issues and contradictions. There is a delicate process to go about due to individuals involved. Under Chris there would be 4-5 senators working on governing document changes. Will be a very inclusive process and environment
 - ii. David Talking about changes to the bylaws and election code, what is your biggest objective?
 - Want to bring about change to recent bylaw changes where judicial branch is de-facto appointed to seats on committees that students could be have and should have an opportunity. Most passionate about reversing last administration's last bylaw. Also want to address election code sanctioning to be straight forward.
 - iii. David You mentioned working on Weeks of Welcome, what is your work there and how much time will you be committing to that outside of IA?
 - As far as WoW event goes 10-20 hours put in, starts at the beginning of the year, majority of my time won't be involved in other projects, but I will be involved as I don't believe it will take away from being Chair of a committee.
 - iv. David Were there any other committees you were interested in being Chair for prior to IA?
 - 1. No IA was always my number, love getting in to the details and specifics. Interested in Admin and Finance as well, but IA is my

number one committee. Student Life allows me to address student needs and desires.

- v. Shannon Were you the only one running for the Chair?
 - 1. I wouldn't know I'm appointed by the Speaker.
- b. Motion for moderated caucus with 3 minutes
 - i. Shannon My perspective is as a new senator, not having any training, I don't feel like I would be able to run a committee being so new.
 - ii. Leen Experience doesn't dictate if someone is knowledgeable and willing to work hard, they should be able to do it and go for it. The WoW event also is on multiple people's shoulders, if he says he can manage time, I believe it.
 - iii. David I think Fahad shows passion and interest, but my concern is if he is dealing with the code he'd be more knowledgeable. I would prefer somebody with a broader view of the bylaws as the chair, I think he'd be a great vice-chair. Hesitant to see him as a chair since he's a sophomore and has later opportunities.
- c. Josh Lucien was an original appointment, his time frame and commitment schedule was difficult to work with. The reason I think he is a good candidate is that you have to be good at managing and delegating can really work. It's not so much experience as it is potential for leadership. I think his structure for IA with two vice-chairs is really a great idea. There are tons of experienced senators on the committee that can assist if need be
 - i. David That's my point it's about training and using the experienced senators that are better qualified chair.
- II. Presidential Appointment of Reda Majidi to Assistant Director of External Affairs 17 0 0
 - a. Reda Humbled to be here today, I'm trying to be the Assistant Director of External Affairs, been doing a 10 years of community work and I'd like to carry that over. I have an internship with a congressman and I think by having the experience I've had in the past long with the internship provides me a great opportunity.
 - i. David What are examples of community service?
 - 1. Part of organizations that did community clean ups with nonprofits and citizens cleaning homes and distributing food. Was able to help Kentucky during a disaster relief period rebuilding homes and helping citizens.
 - ii. Will What is your level?
 - 1. Junior
 - iii. Will What groups are you a part of that are non-political?
 1. United Muslim Relief and Muslim Student Association
 - iv. Laurel Projects you want to do?
 - 1. Community outreach program and UH Day at the Capitol are the
 - two I'm most interested in v. Julien – What have you learned through your experiences?
 - Everyone learns and grows differently and everyone starts and should be treated equally.
 - vi. Sean What gave you the drive to do this?
 - 1. Mom forced me to do it first time and then I realized I loved it and enjoyed it.
 - vii. Zeel Delaney is this addition to Shawn?
 - 1. Yes

viii. Leen – What can you provide to supplement SGA as a whole?

- The two huge projects she's working on and I'd be allocated to go to meetings and events where Delaney she may not be able to do. I'm a helping hand.
- ix. David What's your major?
 - 1. Political Science
- x. Shannon Ample organization to assist elsewhere, why SGA?
 - 1. I like working within politics and government and I just want to be a part of an organization that has a large impact on students
- xi. Will What are some of the interfaith events you've participated in?
 - 1. I haven't participated, but I've attended several.
- III. SGAR-53001: CLASSmates Expansion Resolution Revised 15 0 0
 - a. Leen Little discrepancy with that Classmates is, so we wanted to revise the bill to express what all the Classmates program means and what it truly is. A couple corrections occurred for text issues and also revising the type of bill and moving it to a resolution. The Dean was happy to see the drive by SGA for CLASS.
 - b. Winni The program was created to bring attention to freshman and assist with social settings, there is a lot of a data provided for low retention and graduation rates, so this program was developed to increase those. Dean acknowledged lack of significant data as it isn't entirely collected and managed exhaustively. Survey answers from students showed a desire to expand the program to allow for further work. This bill is to reflect what the students have asked. Questions?
 - i. Shannon I don't understand the program, what is it?
 - 1. Students take classes that are paired with professors and students to build relationships and grow through freshman development
 - ii. Hunter Because funding is limited, would it make sense to take more time to really redevelop a proposal not taking in finances?
 - 1. Honestly the dean wants to push for faculty not staff directly, and so I'm not sure we can get the funding, but we can push. The focus of the bill is expanding the program, not necessarily the funding. So we don't see the wording creating an issue there.
 - iii. Chris Statistics were incorrect?
 - 1. The data isn't incredibly accuracy on CLASS retention rates and then remove Classmates isn't an opportunity, we can see that Classmates is going up, but not how that impacts CLASS.
 - iv. Laurel Should there be textual revisions regarding the classes?
 - 1. The goal is to be inclusive of AP students, we don't have a structure on what classes
 - v. Will Is it a similar program as like in Bauer?
 - No it's a program that combines two classes so you can build better and healthier relationships
 - vi. David Did an associate dean interaction occurred? UH tracks I's given in class, you should double check it.
 - 1. She's in Paris so we couldn't. I have the data you can take a look at currently.
 - vii. Sean Dean brought up majors, would the point of this bill would be beneficial to all majors?
 - We believe the program becomes harder to control when you try and build major based programs to drive. It's easier to keep it put together and keep students interested together. Departmentally the Dean brought up good ideas, but maybe not for Classmates.

- viii. Laurel A lot of CLASS students are Honor's Students, is there a variation for them?
 - 1. Honors wouldn't necessarily be inclusive for them due to their requirements for the program and degree schedule.
- ix. Shannon Couldn't you take the class and request honors credit?
 - 1. No, the only way to make it an honors class is if an honors class is full.
- x. Hunter Previous version was vetoed for taking it to Khator, would it pass your desk today in its current form?
 - 1. I have thoughts, ultimately I have things I want to bring up and even if I were to veto it the Senate can override my veto. I think I have legitimate concerns, I don't want to say yes or no. The very last line is one of my biggest concerns.
- xi. Josh Is there any pressing need to get this pushed now as opposed to tabling it to July?
 - 1. The college is already looking in to expanding it, the bill was to show support for the expansion
- c. Moderated Caucaus 5 minutes
 - i. Chris It's a good resolution, I think they can choose to use it or not, that's their call. I think having the staff member there is really beneficial to the department and the needs of the students. Since the position would be active in more than just one position.
 - ii. Shannon I would just like to say, if it is just a resolution and a suggestion, why not suggest it, especially if this is what the students want. That's what we're here to do.
 - iii. David I agree Shannon's concept my only hesitation point is that if you ask for too much you lose out on the quality content found elsewhere in the bill. Fear of a poisoned pill.
 - iv. Leen Like Winni mentioned, a lot of things stated on this bill, we're reiterating what the college has already asked for and are intending on evaluating expanding on. The only topic of real discussion is a new staff or faculty member to assistance. The dean and director are happy to see this be brought to their attention.
 - v. Andrew I believe that we need to keep in mind this is a resolution and we're here for the students. I think we should be advocating for their desires and needs and if we can't ask the administration for things due to fear of failure then we truly can't advocate. Our goal is to advocate, we should be asking for assistance and help for students especially if it's desired by the students. We're here for the students and this resolution is simply a document supporting an opportunity that CLASS has to expand on a great program for the students.
 - vi. Shane I don't want to ask for the position because I'm not convinced it should receive it. The data does not show that it accomplishes what it says it does. There is no data to show that retention rates have gone up in CLASS. There is no proof to say it does what it says it does. I don't believe the proof is there to ask them where to spend the money. The surveys can be misleading, students in the program may want it, but it may not be beneficial to students with not in the program. I don't disagree with the program, I just don't think the opportunity is there for a staff member. Those are my concerns and I'm not even sure the position

should be allocated and I don't think we can prove it does what it says it does.

- 1. David I think you voice a good opinion, has anyone reached out to hold off bringing the bill to CLASS until we receive data on it?
 - a. Shane I would probably hold up on the bill to get information from data in order from the University
- 2. Hunter Would it be possible to get the support from you if we held on to the bill?
 - a. I'd be happy to evaluate it and probably sign it without the one clause. I hesitate telling the Dean where to spend his money.
- 3. Fahad Would softening the resolution language about a staff position help get to be more agreeable on the matter?
 - a. I believe it could be discussed, but I'm concerned if that is the best place to put a position assuming funding is even there found in CLASS.
- vii. Authors Statistics I knew weren't great, but we're not arguing about all those statistics, the Dean is working on getting us the information needed for Classmates. The Dean today, even if there was 0% impact on retention rates, if students desire it then we'd certainly evaluate it. It's not just about retention rates, it's about everything else programs provide students and students can benefit from. Director of Academic Affairs agrees they need help and I don't believe there isn't any harm in asking for another position. The Dean is even taking this program and trying to emulate this elsewhere in the college investing further time and resources.
