II. SGAR – 56005- Fee Waiver Referendum (First Read)

- This is a referendum to allow students to opt out of paying their Student Fees, if they are in financial need. This resolution creates a referendum to allow students to vote on this bill in the election.
 - I decided to go ahead and get the Student Bodies vote first. I have talked with administrators though.

- The university would determine how undue student fees and deserving members would be affected.
- This would apply to summer, fall and spring semesters.
- If 10 percent of the student body was to waive this 1.2million would go away from SFAC. However, this referendum is a vote for the student body and I believe 10 percent would be too much.
- The university would choose what benefits you do not get if you opt out of the Student Fee.
- The point of this is to have a referendum to gauge student interest.
- I'd rather do the referendum to get this out to more students, IF this were to be heavily interested in then I would work to talk with administrators.
