IIA. The course will have three essay exams and will assign two papers. The live music review will enable the students to understand that writing is contextual (in this case, to a performance that selects American music and presents it to a modern-day audience). Students will utilize the skills of organization, drafting, and revision in the essay exams and the final paper. In particular, the essay exams are designed to require students to synthesize information about different musical genres and cultures that was presented in readings and lectures. This synthesis process requires drafting and revision. The live music review and the research paper will train students in the conventions of writing about music. Through writing the exams, the students will understand and demonstrate through writing the issues of the study of music history and music in its cultural context (see sample exams). In the final paper assignment, students will develop the ability to research and write a documented paper that conforms to the standards of writing in music history and criticism.

IIB. The paper assignments will utilize rubrics for grading. Rubrics will delineate and apply the course goals in detail (as noted in IIA). Copes will be kept of the completed rubrics. These completed rubrics will demonstrate the degree to which the course was effective in regard to its goals.

IIC. Writing guidelines, essay questions, and assignments will be modified during succeeding semesters in response to the information transmitted on the rubrics.
