**Re:** Proposed Freshman Admissions Standards


Attached for your consideration is the proposal and supporting materials for the modification to the previously approved increase in freshman admissions standards. The current proposal arrives at the same standards that were initially proposed, but on a longer timeline and with the addition of an intermediary step. Reviewing the proposed changes with our external constituencies has led us to this modification. We remain committed to increasing our standards, but it is now clear a phased approach to implementation is appropriate.

The newly added intermediary standards are based on an initial class rank threshold of top 15% rather than top 10%. The data suggest the intermediary and final thresholds have a relatively small difference in terms of impact on the FTIC cohort. Nevertheless, the implementation dates are separated by two years, which will give us ample time for Undergraduate Council to examine the impact of the first change in standards before we implement the second.

## University of Houston

### Proposal to Raise Freshman Admission Standards April 7, 2010

Previously the Undergraduate Council approved a proposal to change the Freshman Admission Standards as follows for the Fall 2011 entering cohort:

	Rank in High School Class	SAT/ACT
Level 1: Automatic Admission	Top 10%	No minimum score
Level 2: Automatic Admission	11-25%	1000/21
Level 3: Automatic Admission	26-50%	1100/24
Level 4: Individual Review	51% or lower	

The current proposal moves the originally proposed changes to become effective for the Fall 2014 entering class, and recommends the following standards for the Fall 2012 entering class:

	Rank in High School Class	SAT/ACT
Level 1: Automatic Admission	Top 15%	No minimum score
Level 2: Automatic Admission	16-25%	1000/21
Level 3: Automatic Admission	26-50%	1100/24
Level 4: Individual Review	51% or lower	

Put together, the current proposal is shown below. If approved, the new standards would be implemented in two stages. The first would be used to admit the entering classes of 2012 and 2013, and the second to admit the entering class of 2014 and beyond.

The goals of the current proposal are consistent with those of the original proposal: to make admission to the University of Houston more selective and to improve student success at the university while maintaining student enrollment and diversity. To this end, the impact of the 2012 standards will be reviewed before the 2014 standards are implemented.
