III. New Business

- a. Transfer Admissions Policy (draft 1314) Maureen Croft, Associate Provost, Strategic Enrollment Planning
 - i. Office of Strategic Enrollment Planning has been looking at data concerning the transfer admissions policy since 2014, and after this past year, with more students transferring in than out of the university, feel comfortable with making a recommendation for some changes
 - ii. Would like to raise automatic admission to a 2.5 transfer GPA and have admissions staff conduct individual review on transfer applicants between a 2.25 and 2.5 GPA. Transfer applicants who have previously earned an associate degree would still be held to these admissions standards.
 - iii. Individual review is not a broad-brush approach will be able to look for specific characteristics, experiences, and success indicators; if colleges and/or faculty would like to share their thoughts on individual review criteria, please contact Martha Dunkelberger and she will communicate suggestions to Maureen Croft
 - iv. Concern: what about student coming in with 45+ hours, and being auto-admitted due to 2.5+ gpa, but still not meeting college-specific/major-specific requirements? Too far into college career to be advised on a different path, but already admitted to the university. Response: Individual review will consider the applicant's chosen major
- b. Core Assessment Methods Miguel Ramos
 - i. Continuing earlier discussion of finding faculty members to evaluate Core assignments for reporting purposes; faculty who helped develop the assessment are done with their service, so need to find another group to complete the evaluations
 - ii. Why can't grades be used for assessment? Need aggregate scoring of specific factors, and grades don't address those specific factors
 - iii. Resolution: Miguel's staff will take care of the backlog (with some help from Bekki George, for finding faculty/instructors able to assess Calculus assignments), and, starting in Fall, will ask instructors of courses to complete assessments on own course's work. If no response, Miguel's staff will complete the assessment.
 - iv. Concern over validity of instructor assessing own course there are concerns with any number of methods, trying to do our best with what and who is available.
- c. Mathematics Memo (x2) Rebecca George (memos attached)
 - i. Degree revisions for TeachHouston BS and BA were submitted and approved for the 2016-2017 catalog with an error, requesting a correction to these degree plans (memo attached) correction approved
 - ii. Houston GPS Math Pathways Project requiring changes in Math 1310, 1311, 1312, 1313, and 2311 prerequisites/requirements; Math Dept. requesting the following pre-req changes to courses in order to address this request and align other courses:
 - MATH 1310 College Algebra
 - Prerequisite: A satisfactory score on a placement examination
 - MATH 1311 Elementary Mathematical Modeling
 - Prerequisite: A satisfactory score on a placement examination
 - MATH 1312 Introduction to Mathematical Reasoning
 - Prerequisite: A satisfactory score on a placement examination.
 - MATH 1313 Finite Math with Applications
 - Prerequisite: A satisfactory score on a placement examination.
 - MATH 1314 Calculus for Business and the Life Sciences

- Prerequisite: MATH 1310 or MATH 1311 or a satisfactory score on a placement examination
- MATH 1330 Precalculus
 - Prerequisite: MATH 1310 or a satisfactory score on a placement examination.
- MATH 1431 Calculus I
 - Prerequisite: MATH 1330 or a satisfactory score on a placement examination.
- MATH 2311 Introduction to Probability and Statistics
 - Prerequisite: A satisfactory score on a placement examination.
- iii. Students will need to know that they may need to take additional courses that were previously forced through the pre-requisites. Bekki George and others from the Math department will work with advisors in Technology, Business, and Education, to explain the changes and provide a helpful flowchart for reference
- iv. Need to look further into Math/Reasoning requirements and whether changes to Math 1312, 1313, and 2311 affects their Core eligibility for that component area.
- v. Motion to approve changes for Math 1310, 1311, 1312, 1313, 1314, 1330, 1431, and 2311 approved

 - i. Draft included for military absence policy, needing to be added to the catalog. Once finalized will require an approval from the UC, likely through an email vote, so it can be added to the 2016-2107 catalog.

Proposed First-year Grade Exclusion Policy (Effective Fall 2017)

1. First time freshmen and transfer Students who receive a grade of D+ or below in a course within their first two consecutive long semesters in residence are eligible to repeat the course and have the original grade excluded from the computation of their cumulative grade point average.

- 2. Grade exclusion may only be used once per course and is applicable to a maximum of three courses, only one of which may be at a 3000-level. 4000 and 5000-level courses are ineligible for grade exclusion.
- 3. The course must be repeated at UH within one year of earning the original grade.
- 4. The original course and grade will continue to appear on the student's transcript with a notation that the course was repeated and that the original grade was not included in the computation of the student's cumulative GPA.
- 5. Grade exclusion will not retroactively alter academic actions, decisions, or sanctions that resulted from the original grade or original semester GPA.

A course is not eligible for grade exclusion if the student has violated UH Academic Honesty policy.

- Discussion:
 - Why three courses? Covers the bulk of a semester, in case student was having issues related to transitioning.
 - What does "in residence" mean, and is it necessary to include in the language of the policy? Potential to confuse with a student's residency status.
 - Suggestion to require students to declare their intent to use the policy prior to re-enrolling in the course. Subcommittee didn't want to complicate the policy with additional procedural requirements.
 - Since the intent of the policy is to help students in their transition to UH / help with student success, why is this not a global policy? Why is the petition for grade exclusion necessary?

- Automatic Admission will be extended to all transfer applicants with a 2.50 transfer GPA or higher and at least 15 transfer semester credit hours earned after high school graduation.
- Applicants with fewer than 15 semester credit hours earned after high school graduation must meet freshman admission criteria.
- Applicants who have earned college credits prior to high school graduation are admitted under freshman admissions criteria if they have earned fewer than 15 transfer credit hours post-graduation.
- Applicants with transfer GPAs between 2.25 and 2.50 will be considered for admission through Individual Review of applicant credentials.
- Applicants with transfer GPAs below 2.25 (and those who do not meet Individual Review standards) will be denied admission to UH but offered referral UH Downtown.
- Applicants with Associate's degrees will be considered under the same criteria as others.

Students with Lower Transfer GPAs are Less Likely to Progress Towards a Degree

 On average, first semester GPA is lower than transfer GPA. This relationship is more pronounced for students with a transfer GPA or 2.30 or lower (<u>r</u> = .086, <u>t</u> = -2.12, <u>df</u> = 1, <u>p</u> = <.05).

This memo is to rectify the issue related to the requirement of the analysis component in Math-TeachHouston BS/BA degree programs.

- In our 2014 memo, we requested the removal of the analysis component (MATH3334/MATH3335/MATH3364) from the Math-TeachHouston BS&BA degree requirements. The proposal was approved by UC for the 15-16 UG Catalog.
- In our 2015 memo, we mistakenly referred to the old 14-15 UG Catalog requirements for the Math-TeachHouston BS&BA degree plans when proposing a new one unit course MATH 2131. The proposal was reviewed by a subcommittee and the UC, and approved by the Provost with the language originally proposed. Subsequently, the analysis component (MATH3334/MATH3335/MATH3364) was reinstated in the MATH-TeachHouston BS&BA degree plan for the 16-17 UG Catalog. This was an accidental error.

We request a rectification of this mistake by removing the analysis component (MATH3334/MATH3335/MATH3364) from the degree requirements in the 16-17 UG Catalog for

- Bachelor of Science in Mathematics (teachHouston)
- Bachelor of Arts in Mathematics (teachHouston)

We also request the prerequisite changes for MATH 1310, 1311, 1312, 1313 and 2311 for the 16-17 UG Catalog. These changes are needed to be in compliance with a statewide agreement that is part of a Memorandum of Understanding signed by the Provost and Chancellor of UH.

Our 2014 and 2015 memos together with a memo from the Provost office are enclosed with this memo as attachments.

The Houston Math Pathways project started early in the fall of 2014, as part of an MOU that included the Houston area two- and four-year colleges. The goals of the project included aligning mathematics prerequisites and requirements across two- and four-year schools in the Houston area to aid student transfer and ensure that non-STEM majors have access to core mathematics courses appropriate to their course of study. These same agreements are in place at all two-year colleges and most four-year colleges across the state of Texas. Since that time, mathematics faculty members and staff from the University of Houston (UH), the University of Houston – Downtown (UHD), the University of Houston – Clear Lake (UHCL), San Jacinto College District (SJCD), Houston Community College System (HCC), Wharton County Junior College (WCJC), and Lone Star College System (LSC) have embarked on a 1.5 year process to study student success rates, and investigate statewide mathematics recommendations and requirements for Texas which has led to agreements in line with other two- and four-year institutions across the state.

In the past, the absence of this sort of agreement led to difficulty and confusion for students transferring to the University of Houston. For the University of Houston, the core of these changes amounts to the removal of prerequisites, other than *College Ready*, for Math 1310, 1311, 1313, and 2311. The Department of Mathematics currently gives a math placement exam to all students without college mathematics credit, and *College Ready* will be interpreted at UH as students demonstrating that they can pass the placement exam to enter our Math 1310 or Math 1311.

Undergraduate Committee Target implementation: Fall 2016 Proposal: ADD policy for "Excused Absence for Military Service" in accordance with State guidelines in effect since 2005

In accordance with section 51.9111 of the Texas Education Code and the General Provisions of the Texas Administrative Code Chapter 4, a student is excused from attending classes or engaging in other required activities, including exams, if he or she is called to active military service of a reasonably brief duration.

A student who has been called up for military service after a semester begins should immediately initiate the request for excused absence by providing the course instructors a copy of the military orders.

The student shall be excused from attending class and be allowed to complete an assignment or take an examination from which the student is excused within a reasonable time after the absence.

The maximum period for which a student may be excused as defined by the Texas Higher Education Coordinating Board "shall be no more than 25% (twenty-five percent) of the total number of class meetings or the contact hour equivalent (not including the final examination period) for the specific course or courses in which the student is currently enrolled at the beginning of the period of active military service."

If the absence is for more than 25% of the class meetings, the student may consider withdrawal for military service. Students who withdraw from the University for reasons of military service are provided assistance for military withdrawal under the University of Houston System policy for *Students Called to Active Duty*. <u>http://www.uh.edu/af/universityservices/policies/sam/6AcadmicAffairs/6B1.pdf</u>

Students enrolled in distance learning, hybrid, and other asynchronous courses are to receive equivalent consideration for the purposes of determining acceptable duration of excused absences and time limits for the completion of course work following an excused absence under this policy.

Faculty must retain a student's course work completed during the portion of the course prior to the student being called to active military service and retain the course syllabus or other instructional plan, to ensure that the student is able to complete the course under the same course requirements that were in effect when the student enrolled in the course. Instructors are encouraged to outline for the student before the start of active duty as possible the parameters and deadlines for completing make-up requirements and to make clear the consequences of a student's failure to meet requirements by the agreed upon deadlines.

Should any dispute arise as to the student's inability to complete assignments or examinations within a reasonable time after the absence, the student should first seek resolution with the faculty member, the department chair and then the dean of the college under which the course(s) are taught.

(a) Upon notice from a student required to participate in active military service, an institution shall excuse a student from attending classes or engaging in other required activities, including examinations.

(b) A student shall not be penalized for an absence which is excused under this subsection and shall be allowed to complete an assignment or take an examination from which the student is excused within a reasonable time after the absence.

(c) Each institution shall adopt a policy under this subsection which includes:

(1) the retention of a student's course work completed during the portion of the course prior to the student being called to active military service;

(2) the course syllabus or other instructional plan, so that the student will be able to complete the course without prejudice and under the same course requirements that were in effect when the student enrolled in the course;

(3) a definition of a reasonable time after the absence for the completion of assignments and examinations;

(4) procedures for failure of a student to satisfactorily complete the assignment or examination within a reasonable time after the absence; and

(5) an institutional dispute resolution process regarding the policy.

(d) The maximum period for which a student may be excused under this section shall be no more than 25% (twenty-five percent) of the total number of class meetings or the contact hour equivalent (not including the final examination period) for the specific course or courses in which the student is currently enrolled at the beginning of the period of active military service.
(e) Institutions are directed to develop and publish policies and procedures to ensure that students enrolled in distance learning, self-paced, correspondence, and other asynchronous courses receive equivalent consideration for the purposes of determining acceptable duration of excused absences and time limits for the completion of course work following an excused absence under this section.

Subject: Submission of 7 CBMs and a degree plan change proposal for the BFA in Playwriting/Dramaturgy

- <u>Justification</u>: The primary reason for the proposed changes is to offer a fuller I. curriculum of specialized playwriting and dramaturgy courses more equivalent to the credit count as well as the depth of experience that BFA theatre students on our other tracks receive (all graduating theatre students receive a BFA in theatre; the specialized tracks are an internal departmental distinction which allow students to focus on a given specialty). The proposed changes will take the Playwriting/Dramaturgy BFA from 57 to 72 in-major credit hours. For comparison, the BFA track in acting requires 81 in-major credit hours, the BFA track in theatre production requires 78 in-major credit hours, and the BFA track in stage management requires 80 in-major credit hours. The proposed new courses replace a lot of open electives in the current BFA Playwriting/Dramaturgy course progression and will not increase the overall credit count for the degree (it will remain at 120 total credits including in-major credits, CORE credits, and electives). The changes also take into account the new roles that recent theatre faculty hires Assistant Professor Keith Byron Kirk, Ph.D. and Distinguished Visiting Professor of Playwriting Theresa Rebeck, Ph.d. now play in teaching ongoing courses within the degree plan. In other words, we now have sufficient faculty to offer a BFA track more comparable to the other tracks in the theatre department in terms of credit hours and scope of training.
- II. <u>Proposed Cuts</u>: We propose striking from the catalog the following courses: THEA 3310—Playwriting I, THEA 3311—Playwriting II, and THEA 4331—Playwriting III. These courses will be replaced by an expanded and newly numbered and titled progression of playwriting and dramaturgy courses.
- III. <u>Proposed Additions (new courses)</u>:
 - a. THEA 3302—Playwriting Workshop: Realism
 - b. THEA 3303—Playwriting Workshop: Non-Realism
 - c. THEA 3304—Playwriting Workshop: Myth & Ritual
 - d. THEA 3305—Playwriting Workshop: Comedy
 - e. THEA 3308—Creative Collaboration
 - f. THEA 3309—Performance Studies Seminar
 - g. THEA 4313—Advanced Playwriting
- IV. <u>Explanation</u>: THEA 3302-05, taught by Prof. Shimko, will constitute a four-year rotating cycle of specialized playwriting workshops. Once course from the cycle will be offered

in order each fall semester, so that in four years a student on the Playwriting/Dramaturgy track will take all four classes. The courses are structured so that it does not matter when a student begins the cycle. The only prerequisites for these workshop courses will be instructor permission. THEA 3308 and 3309, taught by Prof. Kirk, will be offered in alternating spring semesters. Both of those courses have been successfully offered as special topics courses already. THEA 4313, taught by Prof. Rebeck, will replace Playwriting III, which she taught in spring '15 (the course content will remain the same, so this is really just a course title/number change).

- VI. <u>Explanation</u>: THEA 3333 is already in the catalog. We are just proposing that it become a required course for the degree track, as opposed to an elective, which it is currently.

The sole issue with which we dealt since the last meeting was the SGA proposal for a "Grade Replacement" policy, later re-named after discussion to "Grade Exclusion" policy.

At our meeting of May 4, we reached agreement on the wording of a Grade Exclusion policy on which we could all agree. The overriding and most persuasive rationale for the policy is the role it could play in assisting students that struggle academically (and in other ways) in their transition years at the University of Houston. Accordingly, the policy is framed to apply to Freshmen and transfer students only with prescribed limitations in terms of applicable grades, availability of policy, number of courses to which the policy applies and a provision with respect to academic honesty.

The Academic Policies and Procedures subcommittee would like to recommend the approval of the Proposed First-year Grade Exclusion Policy, the wording of which follows.

Proposed First-year Grade Exclusion Policy

- 1. First time freshmen and transfer students who receive a grade of D+ or below in a course within their first two consecutive long semesters in residence are eligible to repeat the course and have the original grade excluded from the computation of their cumulative grade point average.
- 2. Grade exclusion may only be used once per course and is applicable to a maximum of three courses, only one of which may be at a 3000-level. 4000 and 5000-level courses are ineligible for grade exclusion.
- 3. The course must be repeated at UH within one year of earning the original grade.
- 4. The original course and grade will continue to appear on the student's transcript with a notation that the course was repeated and that the original grade was not included in the computation of the student's cumulative GPA.
- 5. Grade exclusion will not retroactively alter academic actions, decisions, or sanctions that resulted from the original grade or original semester GPA.

A course is not eligible for grade exclusion if the student has violated UH Academic Honesty policy.

We would like to request that the catalog for BFA Theatre Degrees feature consistent wording across concentrations in regards to the THEA 1111/1112 production requirements.

We have added BFA concentrations over time, and consistency would help alleviate much confusion. The THEA 1111 is offered in the fall, and THEA 1112 is the spring section. Separating them out in the catalog makes it appear that students need to take double the amount of production hours, and dictates narrowly when they can fulfill this requirement.

Please note that this change keeps the current SCH of the degree at 120.
