I have reviewed the proposal titled SGA Bill to Institute Professor Evaluations when a Student Withdraws from a Class (UCC 0126 10S). I don't have any issues with the idea, and I think the feedback would be helpful to the professor. However, I think the evaluation would need some modification to provide more useful feedback to the professor. Such modification would include a question about why the student was withdrawing from the class (there are many reasons, not just the professor) and how many classes the person attended. In addition, these evaluations should be analyzed separately from the rest of the class as the evaluation is not based on the entire class experience. These evaluations should not be included in the stats for the class, but presented separately to the professor and others who review them (e.g., reviews for Promotion and Tenure, merit etc).
