## **Course Objectives and Student Learning Outcomes**

#### **Learning Outcomes:**

Students will learn, through lectures, computer and theory homeworks, and TA-sessions, to
master econometric tools at a level that, in conjunction with other core-classes, enables the
students to perform statistical analysis of economic models.

- Students will develop their technical skills as a background for doing empirical work to the level expected in graduate economics programs. For this purpose, student will learn to use the econometric software to estimate models on actual economic data.
- Students will learn the basic ideas of advanced econometrics with a focus on empirically relevant tools for academia and business

## **Required Instructional Materials**

In principle, there is not required text book. What you should know is what has been covered in class and only what has been taught in class.

Bruce Hansen: Probability and Statistics for Economists, Princeton University Press 2022. I plan follow this book quite closely, but focusing on the what you really need to know, while the book (as almost all textbooks) have (interesting) extra material, which in my view makes it a bit harder to know what has to be known. Some people like the extra material, and it may very well be useful if you use the book later for your research but do not get bogged down in material not covered. Hansen;s book is written by an econometrician and it therefore aims directly at preparing you for econometrics. In terms of difficulty it is somewhat uneven---it aims to cover the statistics that economists *should* know, whether it is ``hard" or not. You may want to consult other books, but do NOT read material that we don't cover, unless you feel that you are so far ahead that you can absorb non-exam stuff.

Other much-used books are, for example,

William Greene: Econometric Analysis. Prentice-Hall. (This is a mainstream econometrics book used numerous places as the main introduction to graduate econometrics. One major goal of the course is to give you the background for texts like that. The book has introductory chapters the list the statistical theory underlying econometrics---the theory this class covers. Greene's summary may be a useful compact source to consult.) There are also ``classic'' books on statistics written for beginning statisticians, ask if want some suggestions, but sometimes these books, while good, are not as directly relevant for economics.

# Course Schedule, Assignments, and Assessments

There will be lectures each Monday and Wednesday and a weekly TA session, usually Friday. There will be weekly homeworks. We will not have computer homeworks in this class, but you might still want to get ready for use statistical software (Stata, R, Matlab). The exact amount of material covered varies a little depending on whether we go deeper into some subjects.

## **Discussion and Lecture Topics**

The class will progress by the order of the Hansen text book. (Note, this year, we have a "math boot camp" which likely covers the first two or three bullet points, if you are not participating in boot camp, you will be assumed to know this material, so in this case you might want to read the first chapters of book yourself. Feel free to ask me what to skip.)

- Chapter 1, Basic Probability. Section 1.1 to 1.10 are all essential. You will encounter combinations and permutations, but I won't ask you to derive them.
- Chapter 2, Random Variables is what you will use during your time at UH. 2.1 to 2.18 are essential.
- Chapter 3, Distributions. The Normal is absolutely essential. We will also thoroughly study the Bernoulli, the uniform, the exponential, the log-normal, the binomial (Meaning that I expect you to know the densities/distribution functions). Other distributions you should know is the chi-square, the F-, the t-distribution, the extreme value distribution, and others. Some we will mention, some we need to know more how to use, but not remember the density.
- Chapter 4, Multivariate Distributions. In particular, you have to know the Normal
  multivariate distribution and the concepts of marginal and conditional distributions. Also,
  the law of iterated expectations is essential.
- Chapter 5, Normal and Related Distributions. We will do most of 5.1-5.9, which is all essential for testing in the linear OLS model in econometrics.
- Chapter 6. Sampling. 6.1-6.14.
- Chapter 7. Somewhat briefly. It is super important that you know "the" Law of Large Numbers (LLN). (There are several versions, but for applied work, this is not usually paid attention to.)
- Chapter 8. Somewhat briefly. It is super important that you know "the" Central Limit Theorem (CLT). (There are several versions, but for applied work, this is not usually paid attention to.)

- Chapter 10. Maximum Likelihood in detail. 10.1-10.15.
- Chapter 13. Hypothesis testing. Concepts of size and power.

### **Grading Rubrics and Weights**

Grades will be based on the midterms (20\% each), home-works (20\%), and final (40\%).

#### **Course Policies and Procedures**

Make sure you understand the material after each topic is covered (don't suffer from the illusion that you will understand it better when exam-time draws near). If the point of some topic is not clear, ask questions in class and see me in my office this is part of good study habits and without good study habits Ph.D. level studies don't go far. I could go on, but you should consider it your duty to yourself to seek advice.
